Special LMC Conference

The BMA called a special conference of representatives of LMCs on Saturday 30 January 2016, to address the unsustainable pressures on General Practice.

The conference held in London, looked at the urgent and immediate actions, and medium and longer-term measures, that are needed to turn around this current workload and workforce crisis, to ensure that GPs can continue to deliver a safe and sustainable service in the future. Sustainability and Transformation Plans (STPs)

The NHS planning guidance is an annual suite of documents that sets out the national priorities, longer-term challenges, financial assumptions and business rules for the coming year.

For the first time, this year's guidance requires NHS leaders to produce two separate but connected plans:

- a one-year operational plan for 2016/17, focused on individual organisations
- a five-year sustainability and transformation plan place-based and driving the *NHS five year forward view*, for the period October 2016 to March 2021.

Sustainability and Transformation Plans (STPs) cover all areas of NHS England and CCG-commissioned activity, and will include better integration with local authority services.

Plans need to address a series of 'national challenges', which fall broadly into three themes:

- ❖ improving health and wellbeing
- ❖ improving quality and developing new models of care
- ❖ improving efficiency to achieve financial balance

Public satisfaction with the NHS in 2015

Since 1983, NatCen Social Research's British Social Attitudes (BSA) survey has asked members of the public about their views on, and feelings towards the NHS and health and care issues.

The latest survey was carried out between July and October 2015 and asked a nationally representative sample of more than 2000 people about their satisfaction with the individual NHS services.

Each year there are higher levels of satisfaction with GPs than any other NHS services, and 2015 is no exception. However, satisfaction with general practice has been falling since 2010, and at 69% in 2015 was the lowest rate recorded since the survey began in 1983.

GP Federations development programme

The LMC's funded development programme for Cheshire GP Federations (those taking a leadership role in the primary care organisations of tomorrow) started on 28 January, at Sandiway Golf Club.

The first of eight half days sessions brought together Federation representatives; GPs, Clinicians and Practice Managers, to learn and share experiences, with the support of external experts.

The focus for the first session was on 'Introduction and set development' – providing an opportunity for colleagues to make contact, start to discuss their similar concerns and uncertainties, and agree the scope and focus of the training programme.

The feedback from the session was excellent, with colleagues expressing a strong sense of emotional and peer support, as well as a sound grounding for the journey ahead.

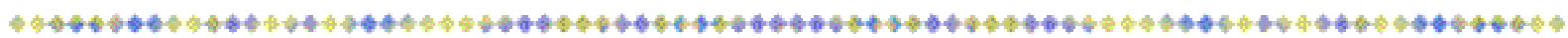

We aim to continue undertaking practice visits throughout the year and we look forward to seeing you in the near future. Email Julie if you would like us to visit you sooner!

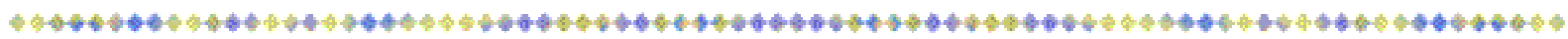

We have started to meet with Practice Manager colleagues at their regular group meetings - considering how we can help to support them by delivering practical workshops or learning sets.

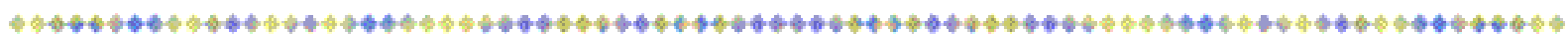
